
### **ATTORNEY'S REPORT**

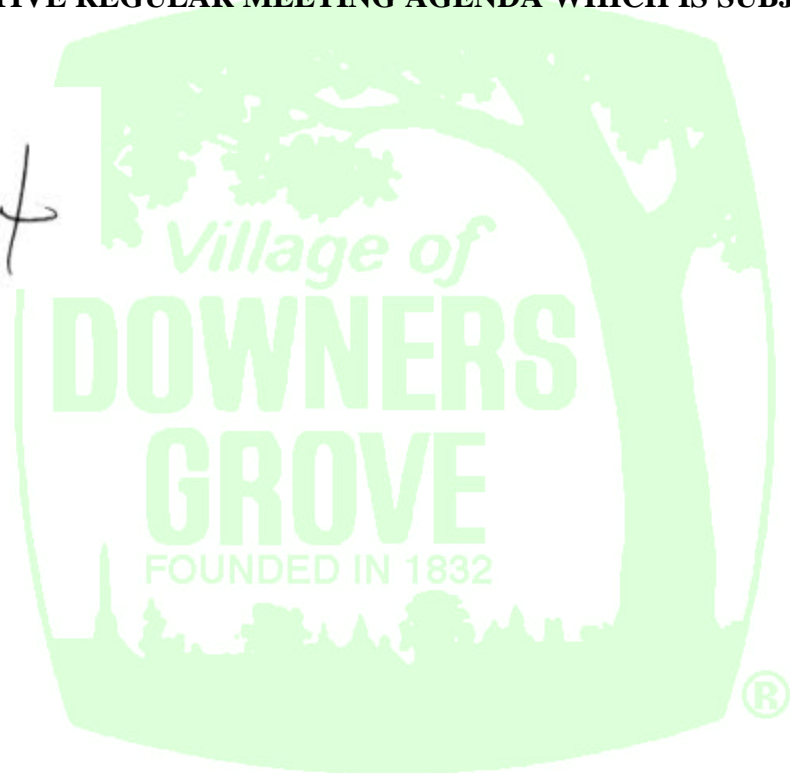
