2. Grant Agreement: Mini-Grant Alcohol Program (MAP)

Purpose: A resolution has been prepared authorizing execution of an agreement between the Village and the Illinois Department of Transportation (IDOT). This agreement in the amount of \$22,272 will support eight Driving Under the Influence (DUI) enforcement campaigns

3. Vehicle Purchase – Fire Public Education Van

Purpose: A motion is requested to approve the purchase of one (1) 2006 dodge Grand Caravan from Downers Grove Dodge of Downers Grove, Illinois as the lowest responsible bidder using the local vendor preference in the amount of \$21,500 for use as the Fire Department Public Education Vehicle
