SYNOPSIS

A resolution has been prepared authorizing submission of a grant application to the Bureau of Justice Assistance requesting federal funding in the amount of \$3,150 to support 50% of the total costs to purchase twelve (12) bullet proof vests.

STRATEGIC PLAN ALIGNMENT

The Five Year Plan and Goals for 2006-2011 identified *Preservation Of The Residential And Neighborhood Character*. A supporting objective of this statement is *Safe And Secure Neighborhoods*.

FISCAL IMPACT

The Council will be obligated to include funding in FY08 General Fund to cover the Village's responsibilities related to the grant. The total estimated project cost for the purchase of twelve (12) bulletproof vests is \$6,300 of which the Village is required to provide \$3,150 as the minimum match.

RECOMMENDATION

Approval on the April 17, 2007 Consent Agenda.

BACKGROUND

Over the past six years, the Village was awarded \$26,085 in grant funds toward the purchase of 129 bulletproof vests as part of the Bulletproof Vest Partnership Program. The Village provides 81 officers and 4 CSO's with vests; with warranty being five years, the Village purchases twenty vests per year to maintain proper replacement. This year the Bureau of Justice Assistance (BJA) limited our total purchase value to a maximum of \$6,300 or an estimated twelve vests. Even though BJA limited our purchase to twelve vests, the PD will budget for a total of twenty vests in 2008 budget year.


