#### SYNOPSIS

A resolution has been prepared to approve a one-year equipment and uniform contract extension with Ray O'Herron Company, Inc. of Lombard, Illinois. Ray O'Herron, Inc. has agreed not to raise original contract pricing more than 2% as required by the Village's purchasing policy. The extension will be effective from January 1<sup>st</sup>, 2011 through December 31<sup>st</sup>, 2011.

The approved FY11 budget includes \$100,062 in the General Fund for these expenses.

# **BACKGROUND**

After completing a competitive bid process in the fall of 2009, the Village awarded a one-year police equipment and uniform contract to Ray O'Herron Company, Inc. of Lombard, Illinois. This contract went into effect January 1<sup>st</sup>, 2010 and will expire on December 31<sup>st</sup>, 2010. However, the contract can be extended for an additional year by mutual agreement of the parties as long as pricing does not increase more than 2%. Ray O'Herron has agreed to keep their price increases within that range. Two, one-year extensions of existing contracts are allowable under the Village's purchasing policy. Staff is pleased with the service provided by Ray O'Herron Company, Inc. and recommends approval of the contract extension.

# EXTENSION TO THE CONTRACT BETWEEN THE VILLAGE OF DOWNERS GROVE AND RAY O'HERRON CO., INC.
