BACKGROUND

The Illinois Department of Transportation (IDOT) plans to resurface Ogden from I-355 to Route 83 in 2019. In conjunction with this work, IDOT requests the Village sign a Letter of Understanding which includes activities the Village currently performs with respect to the Ogden Avenue right-of-way. Three of the five provisions obligating the Village include concurrence with the plans and specifications for the resurfacing work, obtaining IDOT consent prior to the permitting of driveway entrances, and maintenance of pavement markings for intersecting streets. The Village currently complies with the provisions as outlined in the Letter of Understanding.

LETTER OF UNDERSTANDING

The STATE OF ILLINOIS, acting by and through its DEPARTMENT OF TRANSPORTATION, hereinafter called the STATE, is desirous of improving US Route 34 (Ogden Avenue) within the VILLAGE OF DOWNERS GROVE hereinafter referred to as the VILLAGE, in the County of DuPage, Illinois, State Section: 2018-028-RS-SW by making the following improvements:

Roadway resurfacing and constructing ADA compliant curb ramps for sidewalks and installing crosswalk striping on residential streets that intersect with US 34 (Ogden Avenue) within the VILLAGE'S municipal limits, where sidewalk exists on both sides of the street and by performing all other work necessary to complete the improvement in accordance with the approved plans and specifications.

In order that the STATE and the VILLAGE may benefit by this proposed improvement, we are requesting concurrence with the following:

 The STATE agrees to prepare plans and specifications, receive bids and award the contract, furnish engineering inspection during construction and cause the improvement to be built in accordance with the approved plans, specifications, and contract.

- We ask the VILLAGE to sign the plan approval page which is part of this document or provide us with a letter approving the plans and specifications as prepared.
- We ask the VILLAGE not to permit driveway entrance openings to be made in the curb, as constructed, of STATE maintained highways improved as part of our project, without first obtaining STATE consent.
- The STATE will cause private utilities to be relocated at no expense to the STATE or VILLAGE.
- 5. Upon completion of the improvement, the VILLAGE agrees to maintain, or caused to be maintained, all new and existing sidewalks and crosswalk striping along US 34 (Ogden Avenue) and residential streets within the limits of this improvement, within the VILLAGE'S municipal limits.
