#### 4. Public Comments

This is the opportunity for public comments.

1. Frederick Vasquez, a resident of Downers Grove for 35 years, said that they have never had problems with the police. However, they have had a dog-barking problem from spring 2017. He started complaining to the police after four months. Five officers have been contacted and have been there for dog barking. The dog owners said that both dogs are deaf and cannot be trained. The resident asked what he has to do to fight with the dog owner, as he doesn't know the process. #### 8. First Reading

**MOT 2019-8162** — A. Motion: Award \$483,664.50 to Chicagoland Paving Contractors, Inc., Lake Zurich, IL, for Forest North Parking Lot Improvements

Nan Newlon, Director, Public Works, said this is a request to award a contract to Chicagoland Paving Contractors, Inc. for Forest parking lot improvements. She showed the location of the lot between Forest and Main Street that consists of a mix of downtown parking and 3-hour parking. Improvements include replacing pavement and curbs, adding a sidewalk along the north side of Burlington Avenue, replacing storm sewer, adding bioswales, permeable pavers and landscaping to improve the appearance of the parking lot and the water quality. She said the construction is scheduled to begin immediately after RotaryFest with completion before Oktoberfest. Parking has been identified for those displaced during construction. The vendor recommended is the low bidder.

Commissioner Sadowski-Fugitt said she is excited to see the improvements and permeable pavers.

Commissioner Kulovany asked if they have used permeable pavers in parking lots.

Ms. Newlon said not that she is aware of. Mr. Fieldman said that District 99 used them in North High's parking lot.

Ms. Newlon said this are will not get the heavier traffic, and they will only be in a portion of the lot.

Commissioner Kulovany said one of the line items was the removal of 22 trees.

Ms. Newlon said they will be removing 22 trees but adding more landscaping, which will be better for that area.

**ORD 2019-8161** — B. Ordinance: Authorize the Extension of Special Uses to Permit Construction of a Drive-Through Restaurant Facility and a Fueling Station at 2125 Ogden Avenue to October 31, 2019

Stan Popovich, Director, Community Development, explained that this ordinance extends two special uses previously approved. The permit has not yet been issued. Revisions for this request were submitted this morning. The extension of this request is at the discretion of the Council, and two 6-month extensions can be approved.

Mr. Fieldman noted that the petitioner submitted a re-submittal for the building permit this morning.

Petitioner Sean O'Leary said that they are asking for the extension on their special uses for Power Mart. They are moving forward with the project and will go to demolition once the permits are issued. The main reason the project was delayed is due to an engineering firm that is no longer in business. They are happy with where things are regarding the project, and are looking at a six-month window for completion.

Commissioner Kulovany asked whether there are any material changes being made.

Mr. O'Leary replied that it is a convenient store and restaurant, and there is no material change that he is aware of.

Commissioner Kulovany asked whether there has been any resolution regarding the alley vacation.

Mr. Fieldman responded that it was addressed and resolved.

### 9. Mayor's Report

Mayor Barnett said tonight's meeting is the last meeting before Memorial Day, Monday, May 27. Alexander Bradley Burns American Legion Post 80 will hold their 100th Memorial Day observance for the Village at 10:45 a.m. on Monday when they will parade from Main Street to Fishel Park with an observance beginning at 11:00 a.m. All are welcome and encouraged to attend. He provided historical information regarding the celebration of Memorial Day. There are competing claims to the place and origin of Memorial Day but in 1966 Congress and President Lyndon Johnson declared Waterloo, New York, the birth place of Memorial Day based on a ceremony which took place there on May 5, 1866 honoring local veterans who had fought in the Civil War. By the end of the 19th century, Memorial Day ceremonies were being held on May 30 throughout the nation and state legislatures passed proclamations designating the day, and the Army and Navy adopted regulations for proper observance at their facilities. It was not until after World War I that the day was expanded to honor those who died in all American wars. In 1971, Memorial Day was declared a national holiday by an Act of Congress. It was then placed on the last Monday in May.

He requested that Americans observe the real meaning of Memorial Day, which is honoring those who lost their lives by serving in the armed forces. He asked that people pause for one minute at 3:00 p.m. on Monday to reflect on those who died serving in the military. He also suggested that people raise the flag at half-staff until noon and then raise it to full staff for the rest of the day.
