V. NEW BUSINESS

Introduce new members

Ms. Borman and Mr. Iovinelli were appointed to the Stormwater and Floodplain Oversight Committee at the Village Council meeting on Tuesday, September 3. All committee members introduced themselves.

VI. STAFF REPORT

A. 2014 Stormwater Project Analysis (SPA) Projects

Elm/Earlston north of Ogden – contract awarded, construction to start in the next few weeks
Linden – construction underway, to be complete this fall
Burlington Highlands (40th and Downers) – under design, construction planned in the spring
Hobson Triangle – under design, construction planned in the spring
Deer Creek – project out to bid, construction planned to start mid-October

B. St Joe South Water Quality (between Main and Barth Pond)

The design/build contract was recently awarded. Design and permitting this fall/winter with construction to begin in the spring. The project is funded in part by IEPA and DuPage County water quality grants. The project focuses on water quality and stream bank stabilization. Six lots at Webster and St Joseph Creek have been purchased over the last few years. These lots will be incorporated into the project.

C. New Flood Insurance Rate Maps

New FEMA floodplain maps became effective August 1, 2019. Letters were mailed to all property owners with structures newly mapped into the floodplain.

D. DuPage County St Joseph Creek Watershed Plan

Draft plan expected this fall with the final plan expected in the beginning of 2020.

VII. OLD BUSINESS

Mr. Ruyle asked about maintenance for the permeable pavers on Grove Street. The sides of the street (in the parking area) have vegetation growing in the cracks. What is the maintenance plan? Staff will look into this and report back.
