SYNOPSIS

A resolution has been prepared to authorize a contract extension with Elmhurst Chicago Stone Company of Elmhurst, Illinois for supply of ready mix concrete until December 31, 2020. The contract price shall increase by 2% which is an increase of \$298 for a total not to exceed amount of \$15,198.

STRATEGIC PLAN ALIGNMENT

The goals for 2019-2021 include *Top Quality Infrastructure*.

FISCAL IMPACT

The FY20 Budget includes \$16,000 in the General Fund for the supply of ready mix concrete.

RECOMMENDATION

Approval on the January 14, 2020 consent agenda.

BACKGROUND

The contract amount is based on approximately 110 yards of ready mix concrete required for Public Works street, storm water and water utility system maintenance. The vendor has agreed to extend the contract until December 31, 2020.

**A RESOLUTION AUTHORIZING EXECUTION OF AN EXTENSION

4. That all resolutions or parts of resolutions in conflict with the provisions of this Resolution are hereby repealed.

5. That this Resolution shall be in full force and effect from and after its passage as provided by law.

**EXTENSION TO THE CONTRACT BETWEEN
