1. Call to Order

Mayor Barnett said the Village continues to do its part to facilitate the Governor’s stay at home order and to be mindful of social distancing. He announced that the majority of the Council team is participating by conference call including Commissioners José, Earl, Walus, Sadowski-Fugitt, Kulovany and Gray, and Village Clerk Megan Miles. Present in the Committee Room in Village Hall are Mayor Barnett, Village Manager Dave Fieldman, Deputy Village Manager Michael Baker, and Village Attorney Enza Petrarca. The meeting was held in the Committee Room in an effort to improve the audio quality for those listening and participating. Public input was solicited prior to the meeting via a variety of sources. That information will be placed into the public record of this meeting. The Mayor said that every attempt will be made to respond to comments made at the end of the meeting in the comments section, but noted that in some cases a reply may take longer.

9. Mayor and Council Member Reports

Commissioner José reminded everyone that this is Police Week. He thanked the brave Downers Grove police officers who put their lives on the line each day to keep the Village safe. He thanked all of those in law enforcement who serve our community. He said it has never been an easy job and noted that one can see on television mask-free protesters screaming in the faces of police officers who are doing their jobs. They face new and different risks in the age of COVID-19. He hopes images like that give everyone pause. There are even more disturbing images around the State. These actions are not to disagree, but to demonize and to create an argument. This is unacceptable. We share a community and common goals, a safe return to normalcy. He urged people to debate in a safe and civilized manner. He thanked everyone who has done just that.

Commissioner Earl said the uptick in frustration is palpable. She urged people to give each other a break and to show grace. However we get there, we are all going to go together. Pointing fingers and name-calling is not helping the situation. She urged people to share their ideas.

Commissioner Gray said the Village is working hard for all of us. He thanked an individual of the Village. It is hard to see how much work is going on behind the scenes.

Commissioner Kulovany thanked the residents for following the guidelines as well as the staff for their work and to the businesses that are struggling and trying to persevere. He said he is data driven. He said he called six restaurants. The businesses are down 60 to 80%. He encouraged people to continue to frequent the businesses by ordering out.

Commissioner Sadowski-Fugitt expressed her thanks to the Downers Grove Police Department. She also noted that this is National Hospital Week and thanked all healthcare workers. She appreciates everyone complying with the State orders. She asked that people respect and give empathy to those making decisions and to keep in mind that this is a virus no one has ever seen. She said she looks forward to June and beyond.

Commissioner Walus urged people to continue to support local businesses, to show patience, kindness and understanding. She also thanked the Police Department for their work.

Mayor Barnett said the Council represents the residents. How we treat each other is important. He urged people to heed the advice of the Council.

Mayor Barnett said he had one order of business. A liquor license application was received for a Class R-1, full liquor, on-premise consumption from Brinker Restaurant Corporation, doing business as Chili's Bar and Grill, located at 1330A W. 75th Street. Pursuant to Section 3.12 of the Liquor Control Ordinance, a hearing may be waived and the application may be placed on file for two weeks subject to public comment prior to the issuance of the new license. The Mayor said he is placing the application on file in the Clerk's Office at this time. Barring any objection once the two-week waiting period has passed, a liquor license shall be issued.

10. Public Comments

Deputy Village Manager Mike Baker said there were no public comments during the course of the meeting, but a few e-comments were received prior to the meeting.

The Mayor said three remarks were received related to where the Village stands relative to the opening of the State. The Mayor said the stay-at-home order is an Executive Order issued by Governor Pritzker and applies to the entire State of Illinois. The Village, like all other municipalities, does not have the authority to lift or amend

the order. Further, the Village will not direct anyone to act in ways inconsistent with the order. The Village is committed to promoting and protecting the physical and economic wellbeing of our residents and businesses. To that end, we are participating in a County-wide effort led by the DuPage Mayors and Managers Conference, Choose DuPage, the economic development agency for the County, and the DuPage County Health Department preparing recommendations for the Governor to consider further modifying the order and the Restore Illinois Plan to safely reopen our local and regional economy. This effort will result in the publication of a Reopen DuPage Plan presented to Governor Pritzker soon. We encourage everyone to continue to voluntarily comply with the Governor's order. Since the authority to enact and modify the order rests entirely with the Governor, this Village stands ready to work cooperatively with Governor Pritzker as he considers next steps.

11. Adjournment

Mayor Barnett asked for a motion to adjourn.
