SYNOPSIS

A resolution has been prepared to authorize a contract extension for the provision of roadside drainage ditch reconstruction and maintenance services to Western Gradall Corporation of Naperville, Illinois in the amount of \$44,570.

STRATEGIC PLAN ALIGNMENT

The goals for 2019-2021 include *Top Quality Infrastructure*.

FISCAL IMPACT

The FY21 Budget includes \$45,470 in the Storm Water Fund for roadside drainage ditch reconstruction and maintenance services.

RECOMMENDATION

Approval on the January 12, 2021 consent agenda.

BACKGROUND

The 2006 Stormwater Master Plan Update identified roadway drainage ditch cleaning (re-grading) as a key maintenance activity for the Village's stormwater system. Work is planned to be performed between April and September of this year. The contract amount would result in approximately 7,000 linear feet of drainage ditch maintenance being completed in 2021.

The original contract was awarded in March 2019. The contractor has agreed to the same rates as in 2019.

**EXTENSION TO THE CONTRACT BETWEEN

The Village of Downers Grove, Illinois and Western Gradall Corporation ("Provider") entered into a contract for Roadside Ditch Maintenance Services on or about March 13, 2019. Pursuant to the terms stated therein, the parties desire to extend that contract under the following terms:

2. The Provider agrees to provide services at the same rates as listed in the 2019 contract for a total not-to-exceed price of \$44,570
3. All other terms from the March 13, 2019 contract remain in full force and effect.
