**SYNOPSIS**

A resolution has been prepared to authorize a contract extension with Elmhurst Chicago Stone Company of Elmhurst, Illinois for the supply of ready mix concrete until December 31, 2021. The contract price shall increase by 2% for a total not to exceed price of \$15,501.98.

**FISCAL IMPACT**

The FY21 Budget includes \$16,000 in the General Fund for this contract.

**RECOMMENDATION**

**BACKGROUND**

The contract amount is based on approximately 110 yards of ready mix concrete required for street, stormwater and water utility system maintenance. The vendor has agreed to extend the contract until December 31, 2021.

4. That all resolutions or parts of resolutions in conflict with the provisions of this Resolution are hereby repealed.

ELMHURST CHICAGO STONE COMPANY**


The Village of Downers Grove, Illinois and Elmhurst Chicago Stone Company ("Provider") entered into a contract for Supply of Ready Mix Concrete on or about February 12, 2019. Pursuant to the terms stated therein, the parties desire to extend that contract under the following terms:

1. This is the second of two optional extensions and the contract shall be extended through December 31, 2021.
2. The fees shall increase by 2%, which is an increase of \$303.96, for a total not-to-exceed new price of \$15,501.98 for 2021.
3. All other terms from the February 12, 2019 contract remain in full force and effect.
