**AN ORDINANCE AMENDING THE
EMERGENCY MEDICAL SERVICE AND TRANSPORTATION FEES**

BE IT ORDAINED by the Council of the Village of Downers Grove, in DuPage County, Illinois, as follows: (Additions are indicated by **shading**; deletions by ~~strikeout~~.)

SECTION 1. That Section 17-28 of the Downers Grove Municipal Code is hereby amended as follows:

17-28. ~~Nonresident~~Emergency Medical Service and Transportation Fee.

(a) ~~A \$300 fee~~ **The following fees** shall be imposed upon each person ~~not a resident of the Village of Downers Grove~~ who uses emergency medical service and/or transportation provided by the Downers Grove Fire Department:

	<u>Residents</u>	<u>Non-Residents</u>
Basic Life Support Calls	\$275	\$350
Advanced Life Support Calls	\$350	\$425
Cardiac Monitor	\$100	\$100
Oxygen	\$ 50	\$ 50
Mileage-per loaded mile	\$ 5	\$ 5

(b) No fee shall be charged to any ~~nonresident~~**person** for emergency medical services provided under the following conditions:

- (1) The ~~nonresident~~**person** is a Village employee and the emergency medical services and/or transportation provided are related to an injury or illness covered by the Village's worker's compensation ~~or Village health insurance~~;
- (2) The ~~nonresident~~**person** dies prior to being admitted to the hospital; or
- (3) The Village Manager or his designee may waive the fee, or a portion of the fee, if he determines that the ~~nonresident~~**person** is incapable of paying the fee.

SECTION 2. That all ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

SECTION 3. That this ordinance shall be in full force and effect from and after its passage and publication in the manner provided by law.
