DISCUSSION:

The Village of Downers Grove received a contract extension from K-Five Construction Corporation of Lemont, IL, on February 5, 2002. This contact was originally bid in 2001 for the supply of Liquid Asphalt Cement used for crack sealing operations. K-Five is willing to provide liquid asphalt for the same price as last year \$1.70 per gallon.

This is the first contract extension with prices remaining at the original contract amount.



