A RESOLUTION AUTHORIZING AN ADDENDUM TO AGREEMENT FOR PROFESSIONAL SERVICES BETWEEN THE VILLAGE OF DOWNERS GROVE AND VERSAR, INC.

BE IT RESOLVED by the Village Council of the Village of Downers Grove, DuPage County, Illinois, as follows:

1. That the form and substance of a certain Addendum to a Professional Services Agreement (the "Agreement"), between the Village of Downers Grove (the "Village") and Versar, Inc. (the "Engineer"), providing for certain amendments to the original professional services agreement dated September 18, 2001 for environmental services, as set forth in the form of the Addendum to Agreement submitted to this meeting with the recommendation of the Village Manager, is hereby approved.

2. That the Village Manager and Village Clerk are hereby respectively authorized and directed for and on behalf of the Village to execute, attest, seal and deliver the Agreement, substantially in the form approved in the foregoing paragraph of this Resolution, together with such changes as the Manager shall deem necessary.

3. That the proper officials, agents and employees of the Village are hereby authorized and directed to take such further action as they may deem necessary or appropriate to perform all obligations and commitments of the Village in accordance with the provisions of the Agreement.

4. That all resolutions or parts of resolutions in conflict with the provisions of this Resolution are hereby repealed.

5. That this Resolution shall be in full force and effect from and after its passage as provided by law.

**ADDENDUM TO AGREEMENT FOR PROFESSIONAL SERVICES
BETWEEN THE VILLAGE OF DOWNERS GROVE AND VERSAR, INC.**

THIS ADDENDUM dated this ____ day of _____, 2002, by and between the Village of Downers Grove, an Illinois municipal corporation (hereinafter referred to as "Owner"), and Versar, Inc., an Illinois corporation (hereinafter referred to as "Engineer"), in consideration of the following mutual covenants, terms and agreements, hereby agree to amend the Agreement for Professional Services Between The Village Of Downers Grove And Versar, Inc. ("Agreement"), dated September 18, 2001, as follows:

1. The following paragraph is inserted as paragraph 1.1.7 of the Agreement:

1.1.7 The total aggregate amount for all Letter Agreements executed between Owner and Engineer pursuant to this Agreement shall not exceed Two Hundred and Twenty-Five Thousand Eight Hundred and Thirty Dollars (\$225,830.00). Any work that will exceed this amount must be approved in writing by Owner prior to commencement of the work.

2. All terms and conditions of the September 18, 2001 Agreement shall apply equally to this Addendum Agreement, including the term of the agreement.
