SUMMARY OF ITEM:

Adoption of this ordinance will authorize the sale of various vehicles owned by the Village of Downers Grove at a public auction conducted on June 28, 2003 by the DuPage Mayors and Managers Conference.

AN ORDINANCE AUTHORIZING THE SALE BY PUBLIC AUCTION OF PERSONAL PROPERTY OWNED BY THE VILLAGE OF DOWNERS GROVE

WHEREAS, the Village Council of the Village of Downers Grove has determined that it is no longer necessary or useful to, or in the best interests of, the Village of Downers Grove to retain ownership of the personal property hereinafter described; and

WHEREAS, the Village of Downers Grove is a home-rule unit pursuant to the laws and constitution of the State of Illinois; and

WHEREAS, the Mayor and Village Council have determined to sell the personal property at the DuPage Mayors and Managers Conference Public Auction to be held on Saturday, June 28, 2003.

NOW, THEREFORE BE IT ORDAINED by the Village Council of the Village of Downers Grove as follows:

Section 1. The provisions set forth in the preamble are hereby incorporated into this ordinance.

Section 2. Pursuant to the home-rule powers of the Village, and the Illinois Municipal Code (65 ILCS 5/11-76-4) the Village Council finds that the following described personal property now owned by the Village of Downers Grove is no longer is necessary or useful to the Village, and the best interests of the Village will be served by its sale:

Unit	Minimum Bid
1991 Ford Mustang	\$1,200.00
1989 Mazda 626	\$1,500.00
1989 Dodge Ram 150	\$1,000.00

Section 3. The Village Manager is authorized and directed to sell the aforementioned personal property now owned by the Village of Downers Grove at the DuPage Mayors and Managers Public Auction on Saturday, June 28, 2003 at the College of DuPage, Glen Ellyn, Illinois, to the highest bidder on said property.

Section 4. That the Village Manager is hereby authorized and may direct the DuPage Mayors and Managers Conference to advertise the sale of the aforementioned personal property in a newspaper published within the community before the date of said public auction.

Section 5. No bid which is less than the minimum price set forth in the list of property to

be sold shall be accepted except as authorized by the Village Manager or his agent.

Section 6. The Village Manager is authorized and may direct the DuPage Mayors and Managers Conference to enter into agreement for the sale of said personal property. The Conference will charge an administrative fee which will come out of the proceeds of the sale of surplus vehicles and equipment.

Section 7. Upon payment of the full auction price, the Village Manager is hereby authorized and directed to convey and transfer title to the aforesaid personal property to the successful bidder.

Section 8. This ordinance shall be in full force and effect from and after its passage and approval in a manner provided by law.
