SUMMARY OF ITEM:

Adoption of the attached ordinance will amend the commuter and charter bus service rates.

RECORD OF ACTION TAKEN:

AN ORDINANCE AMENDING RATES TO BE CHARGED FOR SERVICE FOR THE VILLAGE OF DOWNERS GROVE BUS SYSTEM

WHEREAS, the Village of Downers Grove has established a bus transportation system to provide services for Village residents and others in the form of set routes and charter service; and,

WHEREAS, it has been the policy of the Council of the Village of Downers Grove to operate such transportation system of the Village as a self-supported enterprise; and,

WHEREAS, the Village Council adopted Ordinance No. 4051 on July 20, 1998 amending established rates charged for such transportation service; and

WHEREAS, the Village Council had determined that it is necessary and desirable to further amend the rates for charter service.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Downers Grove, DuPage County, Illinois, as follows:

SECTION 1. That rates are hereby set for the Downers Grove transportation system as follows:

- 1. *Commuter Service (Effective ~~January 1, 1997~~ June 1, 2003)*
 - A. Monthly \$30.0060.00
 - B. 12 Ride Tickets \$12.0026.00
 - C. Single Ride Tickets \$1.253.00

- 2. *Charter Service - Minimum 4 hour booking required (Effective for all charters booked on or after ~~September 1, 1998~~ June 1, 2003)*
 - A. Not-for-profit organizations located within Downers Grove \$35.0040.00
 - B. Charter service for trips within DuPage County \$45.0050.00
 - C. Charter service for trips outside of DuPage County \$50.0055.00

- 3. *Bristol Club Route (Effective ~~January 1, 1997~~ June 1, 2003)*
 - A. Hourly \$ 33.6043.60

SECTION 2. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

SECTION 3. This ordinance shall be in full force and effect ten days after its passage and publication in the manner provided by law .
