SYNOPSIS

An ordinance has been prepared to amend the Parking Code to implement parking restrictions on both sides of Puffer Road, between Chicago Avenue to the South End.

STRATEGIC PLAN ALIGNMENT

The Vision for 2021 identified Downers Grove as *Beautiful Village with Unique Neighborhoods*. A supporting objective of this statement is *Top Quality Infrastructure Tailored to Each Neighborhood*.

UPDATE & RECOMMENDATION

This item was discussed at the October 24, 2006 Village Council Workshop. Approval is recommended on the November 7, 2006 Active Agenda.

BACKGROUND

This item evolved out of the roadway improvement project along Puffer Road which extended the street a distance of about 150'. During the neighborhood meeting held in 2005 related to this improvement the neighbors offered suggestions and one of these was to restrict parking on this section of roadway.

This section of Puffer Road is extremely narrow by any roadway standards, and as such, there is barely space for one vehicle to traverse the roadway. With approximately six homes in this section, on-street parking is not possible without blocking off the roadway entirely. The neighbors support the proposed change of No Parking Anytime for both sides of Puffer Road. This same restriction is currently posted on Puffer Road, between Chicago Avenue and the north end. This matter was reviewed by the Parking & Traffic Commission and they support adding the No Parking restriction in this section of Puffer Road.

ORDINANCE NO. _____

AN ORDINANCE RESTRICTING CERTAIN PARKING ON PUFFER ROAD

BE IT ORDAINED by the Village Council of the Village of Downers Grove in DuPage County, Illinois, as follows: (Additions are indicated by **shading**/underline; deletions by ~~strikeout~~):

Section 1. That Section 14.98 is hereby amended to read as follows:

14.98 No parking zones-Generally.

No person shall park or let stand, any automobile, motor vehicle or other vehicle at any time in any of the following locations:

Puffer Road, on both sides, from Chicago Avenue south to its dead end.

Section 2. That all ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

Section 3. That this ordinance shall be in full force and effect from and after its passage and publication in the manner provided by law.
