Mr. Puzen asked Mr. Gardner to make sure people on the sidewalk would be safe due to all the vehicles going in and out. Mr. Gardner mentioned there would be no entry fee, but would recommend a \$10 donation, but would not mandatory.

Ms. Szydlowski stated there was talk on social media about losing spaces by going to 75 spots. Mr. Gardner explained that this would help it be more controlled, as opposed to last year when there were more. Ms. Venezia explained that when Downtown Management hosted the event, which was only permitted for Curtiss. Cars that were parking elsewhere on Main Street were not part of the car show.

Mr. Gardner further explained that they would be there around 3 to setup and needed a minimum of four volunteers but could use more. there at 3 to setup tent and plan. Signage up for traffic to know where to go. Ms. Venezia said there would be live entertainment at the train station also. Mr. Puzen once again reiterated concern for pedestrian safety, but stated it sounded like they had a good plan for that.

Mr. Puzen made a motion to approve Car Cruise Night. Ms. Faber seconded the motion.
